Location:

The festival will be held at Station Square at Prairie Crossing. Station Square is located in Grayslake, IL off of Route 137/ Buckley Road, 8/10ths of a mile west of Route 45. Directly across from the Metra North Line's Prairie Crossing/Libertyville train station. From Interstate 94, exit at Route 137 and go west approximately 4 miles

Entry Deadline:

Entry forms and checks must be postmarked on or before July 15, 2010.

New Applicants: Submit images per format listed below.

Previous exhibitors: No jury images required

Entry Fee:

\$75.00 for Lake County Art League members

\$95.00 for non-members

Entry Image Submission Formats:

► One CD with 4 jpeg image files, not further compressed, 1024 x 768 pixels. Label CD with titles and artist name and mail with Entry Form and check.

OR

► Email 4 jpeg image files, sized as above, as email attachments to lakecoartleague@gmail.com. Include artist name, telephone number, and titles of works in message text. Please also mail paper *Entry Form* with your check.

Display:

Artists must furnish and set up their own white tents, no larger than 10' x 10', with the appropriate weights or tie-downs and shims. 12' x 12' spaces will be assigned by festival committee. Limit of 2 browser bins.

Cleanup:

Artists will be responsible for leaving their own areas clean.

Cash Awards:

Best of Show, First, Second, and Third Place.

Eligibility:

The show is open to all artists 18 years or older who submit images for jurying or who have been previously accepted to this event. Artists younger than 18 whose work has been accepted may only display in the festival if accompanied by a parent or guardian.

Regulations and Disclaimer of Liability:

No refunds will be made due to artists' cancellations, removal for cause, or acts of God. Exceptions may be made for unusual circumstances at the discretion of the festival committee.

Each artist assumes responsibility for the care, safety, and security of his or her work and property. The Lake County Art League, the Shops at Station Square, and Prairie Crossing assume no responsibility or liability for damage, theft, or lost property. Signed application for participation indicates agreement with these terms.
